Terms and Service

By accepting Lasher Electric services you have accepted and agreed to our terms and conditions.

Agreement:

All agreements will be documented, all work completed will be installed to the CEC code and building regulations governed by the province of Alberta. Any changes, and delays, will be billed accordingly.

Hourly Rate:

The hourly rate is set at \$75 an hour. There is an additional service fee of \$65 added for the first hour. Two or more electricians the hourly rate per person will be as follows: Two electricians \$125 an hour

Changes or Delays:

Any changes after installation or quote will have a minimum one hour fee added to the cost for time and material. Upon arrival any delays when a scheduled appointment cannot be completed a one-hour service fee will be added

Payment:

Payment will be accepted by cash, E-transfer Visa, Mastercard, American Express, Interac, Apple Pay, and Google Pay. Fees for all debit, and other visa types are as follows.

Fee will be \$0.10 per transaction for the following payment type:

Fee will be 2.65% of the total transaction amount for any of the following payment types:

Inserted Chip Cards

Contactless Credit Cards and Devices

Swiped Cards

Swiped Virtual Terminal Payments

Prepaid Gift Cards

Fee will be 3.4% + 15¢ of the total transaction amount for any of the following payment types:

Manually Keyed-In Card Payments

Manually Entered Virtual Terminal Payments

(Inspections) Two payment installments will be required. 1st, after the first inspection is complete. 2nd, will be after the final completion. (No inspections) If work scope does not require an inspection payment will be given as per agreement.

Materials and special equipment:

There will be a 15% additional cost to materials, permits, or special equipment. Any work with a value of over \$2500 in materials, 25% of the material cost will be needed to proceed.

Temporary lighting:

If agreed upon, temporary lights such as pigtail or string lighting will be provided. Any lighting damaged or not returned will be billed accordingly.

Penalties:

Any payment not received after 30 days will be subject to 1.5% late payment fee of total cost, or a lien after 60 days.

Ending of agreement:

Any tampering or signs of unqualified workmanship will result in termination of agreement and the proper authorities being called.

Drywall and Repair:

Lasher Electric takes no responsibility for the damage or repair of drywall during wire installations.

Incident, damage:

In the event that any damaged items, or site property due to incident or other. A discussion between both parties may be required.

Harassment:
